- Refurbishment
 Ongoing management of buildings

Building type:

- At least 18 metres highOR have at least 7 storeys with two residential units

Persons:

- Duty holders during design and construction
 Accountable Person when the building is occupied, to manage structural and fire

Store all building information as structured digital information and manage, maintain and retain this data digitally.
